

DANCER ELIGIBILITY and REGISTRATION RULES

ELIGIBILITY REQUIREMENTS:

- Candidates must have Senior academic standing and be on track to graduate by June.
- Candidates must be a member of an Oregon high school dance team at the time of the OSAA State Championships.
- Team members may apply if all coaches affiliated with their team are members of the DDCA. That team must be an active member of the DDCA and participate in at least two sanctioned competitions during the year, or compete at the OSAA State Championships.

CONDITIONS OF APPLICATION:

- Registration materials and instructions were emailed to the DDCA Membership on November 8th, 2011. Coaches are responsible to register their dancers for All-State.
- All-State Registration is due by December 2, 2011 and must be filled out by the coach. Late registrations will be charged a \$5 late fee, per dancer. CANDIDATES WILL BE DISQUALIFIED if registration is not completed by the coach, by December 16, 2011.
- The All-State registration fee for participants is \$20 per dancer (the registration fee is the same whether dancers register to participate in the All-State Auditions or in the All-State Drop-In Dance Classes only).
- Funds are due immediately upon registration. Please make arrangements to mail your team check to the DDCA Treasurer after registration is complete (the mailing address will appear on the registration invoice). Please mail one check per team. Do NOT send individual checks from dancers or parents. Payments postmarked after December 16, 2011 will be charged a late fee of \$5 per dancer. Payments or walk-in registrations will not be accepted at All-State Auditions.
- No refunds will be given for cancellations or no-shows after registering to participate in All-State. If a candidate is registered for All-State and cancels before paying for their registration, the candidate/team is still responsible to pay the registration fees owed to the DDCA. The team will be invoiced for any outstanding fees.
- We will allow a 24 hour cancellation period, after registration is complete, for any changes or cancellations to a candidate/team's registration. Please contact ddcaoregon@gmail.com to communicate these changes.
- There are no penalties or fees for dancers that need to change their registration status from a participant in the All-State Auditions to a participant in the All-State Drop in classes ONLY, or vice versa, BEFORE December 16th, 2011.
- If there are any issues, changes or complications with your registration or payment that cannot be dealt with online, please email ddcaoregon@gmail.com.

Note: These conditions are set up so the most cost-effective arrangements can be made for All-State. Arrangements for All-State facilities, instructors, judges, assistants, and staff are made based on the number of participants that register for the All-State Auditions and the All-State Drop-In Classes. The amount we pay out fluctuates depending on the number of dancers that register for All-State. If candidates register and do not pay their dues, then the burden of paying for their participation falls onto the DDCA Membership. We are simply trying to prevent this from happening in the future.
